
A BILL FOR AN ACT

RELATING TO EARLY LEARNING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 302L, Hawaii Revised Statutes, is
2 amended by adding a new section to be appropriately designated
3 and to read as follows:

4 "§302L- Public preschools at department of education and
5 charter schools; authority to enter into agreements for use.

6 (a) The office may enter into agreements with the department of
7 education or any charter school existing pursuant to chapter
8 302D, to use available classrooms for public preschool
9 classrooms statewide.

10 (b) The office shall only enter into agreements with the
11 department of education and charter schools for use of
12 classrooms in schools in which there are qualified educational
13 professionals as determined by the office. Priority shall be
14 given to department of education schools and charter schools
15 that serve at-risk children as defined in section 302L-1 and
16 other targeted groups as determined by the office.



1 (c) Preschool classrooms established pursuant to this
2 section shall be in addition to any pre-plus program established
3 pursuant to section 302L-1.7."

4 SECTION 2. Pursuant to section 1 of this Act, the
5 executive office on early learning shall enter into agreements
6 with no more than five public charter schools existing pursuant
7 to chapter 302D, Hawaii Revised Statutes, for the use of
8 available classrooms for public preschool classrooms.

9 SECTION 3. There is appropriated out of the general
10 revenues of the State of Hawaii the sum of \$ or so
11 much thereof as may be necessary for fiscal year 2014-2015 for
12 the executive office on early learning to enter into agreements
13 with the department of education and charter schools for use of
14 available classrooms for use as preschool classrooms.

15 The sum appropriated shall be expended by the executive
16 office on early learning for the purposes of this Act.

17 SECTION 4. New statutory material is underscored.

18 SECTION 5. This Act shall take effect on July 1, 2050;
19 provided that:

20 (1) Section 2 shall be repealed on June 30, 2019; and

21 (2) Section 3 shall take effect on July 1, 2050.
