
A BILL FOR AN ACT

RELATING TO PUBLIC WORKS OF ART.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Act 281, Session Laws of Hawaii 2013, section
2 2, is amended as follows:

3 1. By amending subsection (a) to read:

4 "(a) The comptroller and the state foundation on culture
5 and the arts shall commission a permanent [~~, three-dimensional~~]
6 work of art to portray the life, vision, accomplishments,
7 impact, and legacy of the late United States Senator Daniel K.
8 Inouye [~~se-as~~] to properly honor his memory and to utilize his
9 example as an inspiration for current and future generations."

10 2. By amending subsection (b) to read:

11 "(b) The state foundation on culture and the arts, at the
12 earliest opportunity, shall issue a call for design entries;
13 provided that the design [~~shall include but~~] is not limited to a
14 likeness of Daniel K. Inouye [~~at some stage of his life~~]."

15 3. By repealing subsection (e):

16 ["(e) ~~The state foundation on culture and the arts and the~~
17 ~~department of accounting and general services shall permanently~~"]

4 SECTION 2. Act 281, Session Laws of Hawaii 2013, section
5 3, is amended by amending subsection (b) to read as follows:

6 "(b) The state foundation on culture and the arts, at the
7 earliest opportunity, shall issue a call for design entries;
8 provided that the design [~~shall include but~~] is not limited to a
9 likeness of Patsy T. Mink [~~at some stage of her life~~]."

10 SECTION 3. Act 281, Session Laws of Hawaii 2013, is
11 amended by amending section 4 to read as follows:

12 "SECTION 4. There is appropriated out of the works of art
13 special fund the sum of [~~\$250,000~~] \$ _____ or so much
14 thereof as may be necessary for fiscal year 2013-2014 and the
15 same sum or so much thereof as may be necessary for fiscal year
16 2014-2015 for the comptroller and state foundation on culture
17 and the arts to commission art pursuant to sections 2 and 3 of
18 this Act.

19 The sums appropriated shall be expended by the [~~department~~
20 ~~of accounting and general services~~] state foundation on culture
21 and the arts for the purposes of this Act."

3 SECTION 5. This Act shall take effect on July 1, 2050.
