
A BILL FOR AN ACT

RELATING TO LABOR.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 104-2, Hawaii Revised Statutes, is
2 amended by amending subsection (a) to read as follows:

3 "(a) This chapter shall apply to every contract in excess
4 of \$2,000 for construction of a public work project to which a
5 governmental contracting agency is a party; provided that this
6 chapter shall not apply to experimental and demonstration
7 housing developed pursuant to section 46-15 or housing developed
8 pursuant to chapter 201H if the cost of the project is less than
9 \$500,000 and the eligible bidder or eligible developer is a
10 private nonprofit corporation.

11 For the purposes of this subsection:

12 "Contract" includes but is not limited to any agreement,
13 purchase order, or voucher in excess of \$2,000 for construction
14 of a public work project.

15 "Governmental contracting agency" includes ~~any~~:

16 (1) Any person or entity that causes either directly or
17 indirectly the building or development of a public
18 work[.]; and



1 (2) Public-private partnerships.


2 "Party" includes eligible bidders for and eligible
3 developers of any public work and any housing under chapter
4 201H; provided that this subsection shall not apply to any
5 housing developed under section 46-15 or chapter 201H if the
6 entire cost of the project is less than \$500,000 and the
7 eligible bidder or eligible developer is a private nonprofit
8 corporation.

9 "Public work" means any project, including development of
10 any housing pursuant to section 46-15 or chapter 201H and
11 development, construction, renovation, and maintenance related
12 to refurbishment of any real or personal property, where the
13 funds or resources required to undertake the project are to any
14 extent derived, either directly or indirectly, from public
15 revenues of the State or any county, or from the sale of
16 securities or bonds whose interest or dividends are exempt from
17 state or federal taxes."

18 SECTION 2. Statutory material to be repealed is bracketed
19 and stricken. New statutory material is underscored.

20 SECTION 3. This Act shall take effect upon its approval.
