Status

RELATING TO PUBLIC HEARINGS.

CPC/JUD, FIN

Requires state agencies to hold public hearings in the county, or counties, primarily impacted by the proposed adoption, amendment, or repeal of any administrative rule. Requires at least one public hearing with thirty days' notice on each island that a proposed rule will likely have a significant monetary impact on residents or communities of that island.

RELATING TO REAL ESTATE INVESTMENT TRUSTS.

CPC/JUD, FIN

Disallows dividends paid deduction for Real Estate Investment Trusts.

DECISION MAKING TO FOLLOW



Persons wishing to offer comments should submit testimony no later than 24 hours prior to the hearing. Persons submitting testimony on the day of the hearing **MUST** submit 28 copies at the hearing. Staff will not be able to make copies.

Testimony should indicate:

- Testifier's name with position/title and organization;
- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.

While every effort will be made to incorporate all testimony received, materials received on the day of the hearing or improperly identified or directed, may be distributed to the Committee after the hearing.

Submit testimony in **ONE** of the following ways:

**PAPER:** 28 copies (including an original) to Room 304 in the State Capitol;

**FAX:** For testimony less than 5 pages in length, transmit to 808-586-6211 (Oahu) or 1-800-535-3859 (for Neighbor Islander without a computer to submit testimony through the website); or

**WEB:** For testimony less than 10MB in size, transmit from <http://www.capitol.hawaii.gov/submittestimony.aspx>.

Testimony submitted will be placed on the legislative website. This public posting of testimony on the website should be considered when including personal information in your testimony.
