<a href="#">SB1094</a> <a href="#">Status and Testimony</a>	RELATING TO INSURANCE. Updates title 24 of the Hawaii Revised Statutes relating to insurance.	CPN, WAM
<a href="#">SB736</a> <a href="#">Status and Testimony</a>	RELATING TO INSURANCE. Requires an entity to send written notice to a health care provider at least thirty calendar days prior to initiating any recoupment or offset demand efforts. Prohibits an entity from initiating any recoupment or offset efforts more than twelve months after an initial claim payment was received by a health care provider, with specific exceptions.	CPN, JDL
<a href="#">SB589</a> <a href="#">Status and Testimony</a>	RELATING TO INSURANCE. Requires the renewal of property insurance, but permits insurers to deny renewal for nonpayment of an undisputed premium by a policyholder.	CPN, JDL
<a href="#">SB994</a> <a href="#">Status and Testimony</a>	RELATING TO THE HAWAII PROPERTY INSURANCE ASSOCIATION. Requires member insurers of HPIA to offer a minimum number of policies proportionate to their market share on properties that are situated in the areas designated for coverage by the insurance commissioner and that have been previously and continuously insured since 06/01/2014. Prohibits HPIA from issuing or continuing a moratorium on issuing policies on those same properties.	CPN, JDL

Requires member insurers of HPIA to renew policies that were in effect as of 1/1/2014. Provides for continued coverage under an existing HPIA policy upon a transfer in ownership of the property.

RELATING TO CHARITABLE SOLICITATION.  
Authorizes the Attorney General to require electronic financial reporting by professional solicitors, imposes a late fee for late financial reports by professional solicitors; and clarifies exemptions from registration requirements.
