Requires and appropriates funds for the department of education to develop an assessment in the Hawaiian language of established statewide performance standards for students in the ka papahana kaiapuni program by the 2020-2021 school year. Requires reports to the legislature. (SB778 HD1)	OMH, EDN, FIN
<u>SB 980, SD1, HD1</u> <u>(HSCR928)</u> <u>Status</u>	RELATING TO AFTERSCHOOL PROGRAMS. Establishes the R.E.A.C.H. (Resources for Enrichment, Athletics, Culture, and Health) program in the Office of Youth Services to provide a standardized framework and funding for afterschool programs in public middle schools. Establishes a R.E.A.C.H. program special fund. (SB980 HD1)	HUS, EDN, FIN
<u>SB 64, SD3</u> <u>(HSCR927)</u> <u>Status</u>	RELATING TO HUMAN SERVICES. Makes appropriations for positions and the continued implementation of the preschool open doors program and for subsidies for the program. Effective 7/1/2050. (SD3)	HUS, EDN, FIN
<u>SB 1346, HD1</u> <u>(HSCR924)</u> <u>Status</u>	RELATING TO TEACHERS. Sets probationary period of specified licensed charter school teachers according to policies and practices as determined by DOE, BOE, and collective bargaining agreements. Subjects tenured DOE licensed teachers who transfer to charter schools to the appropriate collective bargaining agreement. (SB1346 HD1)	LAB, EDN, FIN
