Requires the Legislative Reference Bureau to conduct a study on the applicability of the state civil service law and collective bargaining to persons employed by the Research Corporation of the University of Hawaii. (HB556 HD1)	LAB, HED, FIN
<u>HB 850, HD1</u> <u>(HSCR75)</u> <u>Status</u>	RELATING TO THE AGRICULTURAL EXTENSION SERVICE. Appropriates funds for critical positions in the cooperative extension service administered by the UH College of Tropical Agriculture and Human Resources. (HB850 HD1)	AGR, HED, FIN
<u>HB 870, HD1</u> <u>(HSCR73)</u> <u>Status</u>	RELATING TO FOOD. Authorizes the issuance of general obligation bonds and appropriates funds for the Kapiolani Community College Food Innovation Center to produce prepared meals using locally grown food for organizations that need large quantities of meals on a daily basis. Appropriates moneys to the Local and Immigrant Farmer Education Program of the UH College of Tropical Agriculture and Human Resources Cooperative Extension Service to support the growth and sustainability of the agriculture industry.

Status

RELATING TO THE SELECTIVE SERVICE REGISTRATION AWARENESS AND COMPLIANCE ACT.

VMI, HED, FIN

Requires compliance with the Military Selective Service Act to be eligible for enrollment in a state-supported post-secondary institution, qualify for state financial assistance for post-secondary education, or be eligible for state or county employment or service. Provides exceptions.

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- Testifier's name with position/title and organization;
- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.

While every effort will be made to incorporate all testimony received, materials received on the day of the hearing or improperly identified or directed, may be distributed to the Committee after the hearing.



WHEN SUBMITTING WRITTEN TESTIMONY AT THE HEARING: please bring 20 copies for committee members.
