Appropriates funds from the office of health care assurance special fund to administer the durable medical equipment licensing program. Exempts licensing provisions from sunrise review. RELATING TO AGING.
Part I: Appropriates funds for the kupuna care program and an aging and disability resource center. Part II: Removes hiring requirement by director of health in accordance with chapters 76 and 89, Hawaii Revised Statutes, for the position of Alzheimer's disease and related dementia services coordinator. Appropriates funds for the Alzheimer's disease and related dementia services coordinator. Part III: Appropriates funds for fall prevention and early detection services for the elderly. Part IV: Appropriates funds to support the healthy aging partnership program. Part V: Appropriates funds for an Alzheimer's disease and related dementia public awareness campaign. Effective 7/1/2050. (SD2)

DECISION MAKING TO FOLLOW
