<a href="#"><u>HB 858, HD2, SD1</u></a> <a href="#"><u>(SSCR994)</u></a> <a href="#"><u>Status &amp; Testimony</u></a>	RELATING TO DOMESTIC VIOLENCE. Permits the termination of residential rental agreements in cases of domestic violence. Specifies additional procedures under the residential landlord-tenant code for instances of domestic violence. Takes effect 11/01/2015. (SD1)	CPN, JDL
