<u>HB 621, HD1</u> <u>(HSCR219)</u> <u>Status</u>	RELATING TO ENVIRONMENTAL PROTECTION. Gradually prohibits the manufacture and sale of personal care products containing synthetic plastic microbeads to protect marine life. (HB621 HD1)	EEP, OMH, CPC
<u>HB 142, HD1</u> <u>(HSCR6)</u> <u>Status</u>	RELATING TO AFFORDABLE HOUSING ON HAWAIIAN HOME LANDS. Extends the sunset date for provisions for affordable housing credits for affordable housing developed on Hawaiian home lands to July 1, 2021.	HSG, OMH, FIN
<u>HB 720</u> <u>Status</u>	RELATING TO THE WEST MAUI OCEAN RECREATION MANAGEMENT AREA. Makes permanent the west Maui ocean recreation management area advisory committee. Adds one member to the committee with a background in ocean safety.	OMH, FIN
<u>HB 869</u> <u>Status</u>	RELATING TO SPINNER DOLPHINS. Prohibits the taking of a spinner dolphin.	OMH, JUD
<u>HB 1297</u> <u>Status</u>	RELATING TO THE PENAL CODE. Provides that the treatment of a corpse in a manner consistent with traditional Hawaiian cultural customs and practices shall not constitute the abuse of a corpse within the penal code.	OMH, JUD
<u>HB 1339</u> <u>Status</u>	RELATING TO SHARK AND MANTA RAY PROTECTION. Creates administrative penalties for any person who knowingly captures, kills, or takes any shark or manta ray within state marine waters. Provides exemptions for native Hawaiian gathering rights and cultural practices, research purposes, and public safety.	OMH, JUD



DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- Testifier's name with position/title and organization;
- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.

While every effort will be made to incorporate all testimony received, materials received on the day of the hearing or improperly identified or directed, may be distributed to the Committee after the hearing.

Submit testimony in ONE of the following ways:

PAPER: 15 copies (including an original) to Room 425 in the State Capitol;

FAX: For testimony less than 5 pages in length, transmit to 808-586-8404 (Oahu) or 1-800-535-3859 (for Neighbor Islander without a computer to submit testimony through e-mail or the Web); or

WEB: For testimony less than 10MB in size, transmit from <http://www.capitol.hawaii.gov/submittestimony.aspx>.

Testimony submitted will be placed on the legislative website. This public posting of testimony on the website should be considered when including personal information in your testimony.
