| <p><b><u>SB 611</u></b><br/><a href="#">Status &amp; Testimony</a></p> | <p>RELATING TO USE OF INTOXICANTS WHILE OPERATING A VEHICLE.<br/>Allows an ignition interlock permit holder to take necessary tests to apply for relicensing during the final 30 days of the revocation period. Prohibits operating a vehicle with an ignition interlock permit without a state identification card. Prohibits operating a vehicle once a notice of administrative record has expired unless the driver has a valid driver's license.</p>  | <p>TRA, JDL</p>     |
| <p><b><u>SB 612</u></b><br/><a href="#">Status &amp; Testimony</a></p> | <p>RELATING TO PROBATION.<br/>Requires a period of probation for any person convicted of the offense of operating a vehicle under the influence of an intoxicant and operating a vehicle after license and privilege have been suspended or revoked for operating a vehicle under the influence of an intoxicant.</p>  | <p>TRA, JDL</p>     |
| <p><b><u>SB 613</u></b><br/><a href="#">Status &amp; Testimony</a></p> | <p>RELATING TO PENALTIES.<br/>Enhances penalties for a conviction of operating a vehicle after license and privilege have been suspended or operating a vehicle under the influence of an intoxicant.</p>  | <p>TRA, JDL</p>     |
| <p><b><u>SB 225</u></b><br/><a href="#">Status &amp; Testimony</a></p> | <p>RELATING TO DRIVING UNDER THE INFLUENCE.<br/>Amends the offense of habitually operating a vehicle under the influence of an intoxicant to include operating a vehicle under the influence of an intoxicant after at least one conviction within the previous ten years for habitually operating a motor vehicle under the influence of an intoxicant.</p>   | <p>TRA, JDL</p>     |
| <p><b><u>SB 321</u></b><br/><a href="#">Status &amp; Testimony</a></p> | <p>RELATING TO OPERATING A VEHICLE WHILE UNDER THE INFLUENCE OF AN INTOXICANT.<br/>Increases the penalty for the offense of operating a vehicle under the influence of an intoxicant to a class C felony if the defendant operated a vehicle with a passenger who was fifteen years of age or younger. Establishes minimum breath and blood alcohol levels for defendants who are between eighteen and twenty-one years of age and convicted of operating a vehicle under the influence of an intoxicant with a passenger who was fifteen years of age or younger.</p> | <p>TRA, JDL/WAM</p> |
