<u>HB 1360, HD1</u> <u>(HSCR640)</u> <u>Status & Testimony</u>	RELATING TO THE DEPARTMENT OF TRANSPORTATION. Authorizes issuance of GO bonds for relocation of the Clear Channel antenna, including design and construction, equipment and appurtenances, and ground and site improvements.	TRA, WAM
<u>HB 1489, HD1</u> <u>(HSCR823)</u> <u>Status & Testimony</u>	RELATING TO SPECIAL LICENSE PLATES FOR NATIONAL PARKS. Authorizes the issuance of special license plates for Haleakala National Park and Hawaii Volcanoes National Park. (HB1489 HD1)	TRA, WAM
