### A BILL FOR AN ACT

RELATING TO THE MINIMUM WAGE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii's minimum
- 2 wage should be increased to meet workers' basic needs.
- 3 According to the department of business, economic development,
- 4 and tourism, a single adult required an income of \$35,143 to
- 5 achieve self-sufficiency in Hawaii in 2018, while a single
- 6 parent with one child required \$59,428. Yet, at the current
- 7 statewide minimum wage rate of \$10.10 per hour, a full-time
- 8 employee earns only \$21,008 annually. Moreover, the National
- 9 Low Income Housing Coalition's Out of Reach 2018 report
- 10 estimates that a minimum wage worker would have to work one
- 11 hundred nine hours per week to afford a one-bedroom rental home
- 12 at local fair market rent.
- 13 The legislature further finds that increasing the State's
- 14 minimum wage will help Hawaii's economy by giving low wage
- 15 workers greater purchasing power in Hawaii's marketplace.
- 16 Additionally, according to the department of labor and
- 17 industrial relations, in 2018 and the following four consecutive

1 years of minimum wage increases, the State's unemployment level 2 reached an all-time low of two per cent, demonstrating that 3 increasing the minimum wage does not adversely impact statewide 4 employment. 5 The purpose of this Act is to support Hawaii's workforce 6 and essential workers by increasing the minimum wage rate in the 7 State. 8 SECTION 2. Section 387-2, Hawaii Revised Statutes, is 9 amended to read as follows: 10 "§387-2 Minimum wages. (a) Except as provided in section 11 387-9 and this section, every employer shall pay to each 12 employee employed by the employer, wages at the rate of not less 13 than: 14 (1)\$6.25 per hour beginning January 1, 2003; 15 (2) \$6.75 per hour beginning January 1, 2006; 16 \$7.25 per hour beginning January 1, 2007; (3) 17 (4)\$7.75 per hour beginning January 1, 2015;

\$8.50 per hour beginning January 1, 2016;

\$10.10 per hour beginning January 1, 2018.

\$9.25 per hour beginning January 1, 2017; and

1 self-sufficiency income standard for one adult in the State 2 would result in a lower hourly minimum wage rate, the adjusted 3 hourly minimum wage rate shall remain the same as the hourly 4 minimum wage rate in effect for the year in which it is 5 calculated. Each adjusted hourly minimum wage rate calculated 6 under this subsection shall take effect on July 1 of the 7 calendar year in which the adjusted hourly minimum wage rate is 8 calculated; provided that if an increase in the adjusted hourly 9 minimum wage rate exceeds ten per cent of the hourly minimum 10 wage rate in effect for the year in which it is calculated, the 11 adjusted hourly minimum wage rate shall be increased by ten per 12 cent of the hourly minimum wage rate in effect for the year in 13 which it is calculated." 14 SECTION 3. Statutory material to be repealed is bracketed 15 and stricken. New statutory material is underscored. 16 SECTION 4. This Act shall take effect on July 1, 2022.

#### Report Title:

Maui County Council Package; Minimum Wage

### Description:

Requires that beginning on 1/1/2026, and each year thereafter, the adjusted minimum wage rate to be recalculated using the most recent self-sufficiency income standard for one adult in the State of Hawaii. Requires that the adjusted minimum wage go into effect starting 7/1/2026 and each year thereafter. Repeals the tip credit.
